The undersigned parent or guardian of Minor for him/herself, his/hers heirs, executors, administrators, or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against Faith Presbyterian Church or its officers, agents, servants or employees, the undersigned parent or guardian will indemnify and hold harmless Faith Presbyterian Church and its officers, agents, servants, or employees from any and all claims or action by Minor or by any other person or entity, by Whomever or wherever made or presented, and under no circumstances will the undersigned parent or guardian of Minor present any claim against Faith Presbyterian Church and said persons for personal injuries, property damage, wrongful death, or otherwise, caused by any act of negligence by Faith Presbyterian Church and said persons.

The undersigned parent or legal guardian intends his or her signature to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.
